Resolutions 9-11 will be proposed as special resolutions which means that for such resolutions to be passed, at least 75 per cent of votes cast must be in favour.

Resolution 1 The Report and Accounts

The directors of the Company ("Directors") are legally required to present their report and the audited accounts before the members at an Annual General Meeting. Resolution 2-5 Annual re-election of Directors

22. As at 10 June 2022 (the latest practicable date before publication of the Notice) the Company's issued ordinary share capital consisted of 28,941,234 ordinary shares, carrying one vote each. There are no treasury shares in issue. Therefore, the total voting rights in the Company as at 10 June 2022 were 28,941,234.
